**FINDINGS AND DECISION**

The duly constituted Electoral Board, consisting of Board of Election Commissioners for the City of Chicago Commissioners Marisel A. Hernandez, Langdon D. Neal, and William J. Kresse, organized by law in response to a Call issued by Marisel A. Hernandez, Chairman of said Electoral Board, for the purpose of hearing and passing upon objections (“Objections”) of Vanessa Simonvic and Steve Greznia (“Objectors”) to the nomination papers (“Nomination Papers”) of Grasiela Rodriguez, candidate for the nomination of the Democratic Party for the office of Representative in the General Assembly for the 22nd Representative District in the State of Illinois (“Candidate”) at the General Primary Election to be held on March 15, 2016, having convened on December 14, 2015, at 9:00 A.M., in Room 800, 69 West Washington Street, Chicago Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate herein were duly timely filed.

2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.

3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objectors and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.

4. A public hearing held on these Objections commenced on December 14, 2015 and was continued from time to time.

5. The Electoral Board assigned this matter to Hearing Officer Lynne Ostfeld for further hearings and proceedings.

6. The Objectors and the Candidate were directed by the Electoral Board's Call served upon them to appear before the Hearing Officer on the date and at the time designated in the Hearing Schedule. The following persons, among others, were present at such hearing: the Objectors, Vanessa Simonvic and Steve Greznia, by their attorneys, Ross Secler and Deborah Moldover; and the Candidate, Grasiela Rodriguez, by her attorney, Scott B. Erdman.


7. The Electoral Board finds that on December 18, 2015 the Objectors filed a motion to withdraw their Objections against the Candidate's Nomination Papers. The Electoral Board grants the Objector's motion to withdraw the Objections and the Objections are withdrawn.

8. The Electoral Board further finds that there are no additional Objections filed against the Candidate's Nomination Papers and, in the absence of any objections thereto, such Nomination Papers are deemed valid.

IT IS THEREFORE ORDERED that the Nomination Papers of Grasiela Rodriguez, candidate for the nomination of the Democratic Party for the office of Representative in the General Assembly for the 22nd Representative District in the State of Illinois, are deemed


VALID and the name of the Candidate SHALL be printed on the official ballot for the General Primary Election to be held on March 15, 2016.


