**FINDINGS AND DECISION**

The duly constituted Electoral Board, consisting of Board of Election Commissioners for the City of Chicago Commissioners Marisel A. Hernandez, Langdon D. Neal, and William J. Kresse, organized by law in response to a Call issued by Marisel A. Hernandez, Chairman of said Electoral Board, for the purpose of hearing and passing upon objections (“Objections”) of Kaylynn M. Vega (“Objector”) to the nomination papers (“Nomination Papers”) of Quintin Barton, candidate for the office of Republican Party Ward Committeeman for the 10th Ward of the City of Chicago (“Candidate”) at the General Primary Election to be held on March 15, 2016, having convened on December 14, 2015, at 9:00 A.M., in Room 800, 69 West Washington Street, Chicago, Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate herein were duly and timely filed.
2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.

3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.

4. A public hearing held on these Objections commenced on December 14, 2015 and was continued from time to time.

5. The Electoral Board assigned this matter to Hearing Officer Yamil Colón for further hearings and proceedings.

6. The Objector and the Candidate were directed by the Electoral Board's Call served upon them to appear before the Hearing Officer on the date and at the time designated in the Hearing Schedule. The following persons, among others, were present at such hearing: the Objector, Kaylynn M. Vega, by her attorney, Sharee S. Langenstein; and the Candidate, Quintin Barton, pro se.

7. The Hearing Officer has tendered to the Electoral Board a report and recommended decision. Based upon the evidence presented, the Hearing Officer found:

A. The Candidate submitted to the Hearing Officer, but did not file with the Electoral Board, a motion to strike and dismiss the Objector's Petition. The motion alleged that the Objector's signature on the Objector's Petition was not genuine, that the Objector failed to provide the name of the circulator who allegedly circulated petitions for a candidate of another party and that the Objector's Petition contained no Appendix-Recapitulation.

B. The Hearing Officer denied the motion to strike the Objector's Petition. Paragraph four of the Objector's Petition alleged that the Candidate simply did not, on the face of the petition, have the required 123 signatures. The Candidate,

after counting the signatures on his nominating petitions, conceded that he had only 119 signatures on the petitions. The Candidate did not present any evidence so support his allegation that the Objector's signature on the Objector's Petition was not genuine.


C. The Hearing Officer found that on their face, the Candidate's nomination petitions contained fewer than the 123 signatures required for the office of Republican Party Ward Committeeman for the 10th Ward of the City of Chicago. Therefore, the Hearing Officer recommends that the Objections be sustained.

8. The Electoral Board, having considered the evidence and arguments tendered by the parties and the Hearing Officer's report of recommended findings and conclusions of law, hereby adopts the Hearing Officer's recommended findings and conclusions of law.

9. For the reasons stated above, the Electoral Board finds that Objections are sustained and that the Candidate's Nomination Papers are invalid.

IT IS THEREFORE ORDERED that the Objections of Kaylynn M. Vega to the Nomination Papers of Quintin Barton, candidate for the office of Republican Party Ward Committeeman for the 10th Ward of the City of Chicago, are hereby SUSTAINED and said Nomination Papers are hereby declared INVALID and the name of Quintin Barton, candidate for the office of Republican Party Ward Committeeman for the 10th Ward of the City of Chicago, SHALL NOT be printed on the official ballot for the General Primary Election to be held on March 15, 2016.
