FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of Board of Election Commissioners for the City of Chicago Commissioners Marisel A. Hernandez, William J. Kresse and Jonathan T. Swain, organized by law in response to a Call issued by Marisel A. Hernandez, Chairman of said Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of La Shawn K. Ford ("Objector") to the nomination papers ("Nominating Papers") of CHRISTOPHER TALIAFERRO, candidate for the office of Democratic Party Ward Committeeman for the 29th Ward of the City of Chicago ("Candidate") at the General Primary Election to be held on March 15, 2016, having convened on December 14, 2015, at 9:00 A.M., in Room 800, 69 West Washington Street, Chicago, Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate herein were duly and timely filed.

- 2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.
- 3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.
- 4. A public hearing held on these Objections commenced on December 14, 2015 and was continued from time to time.
- The Electoral Board assigned this matter to Hearing Officer Mary Celeste
 Meehan for further hearings and proceedings.
- 6. The Objector and the Candidate were directed by the Electoral Board's Call served upon them to appear before the Hearing Officer on the date and at the time designated in the Hearing Schedule. The following persons, among others, were present at such hearing: the Objector, La Shawn K. Ford, by his attorney, Michael J. Kasper; and the Candidate, Christopher Taliaferro, by his attorney, Pericles Abbasi.
- 7. The Hearing Officer ordered that an examination of the Board's voter registration records be conducted by clerks and agents under the Board's direction and supervision, in accordance with the laws of Illinois and the rules of the Board.
- 8. The Hearing Officer directed all parties to appear and be present, either personally and/or by their authorized representatives, during this records examination.
- 9. The Candidate and/or his duly authorized representative was present during the examination of the registration records.
- 10. The Objector and/or his duly authorized representative was present during the examination of the registration records.

- 11. The examination of the registration records of the Board was terminated after it was determined that even if all of the remaining objections to individual signatures on the petition were sustained in favor of the Objector, the Candidate would still have more than the minimum number of valid signature on his nominating petitions to qualify for a place on the ballot as a candidate for the office of Democratic Party Ward Committeeman for the 29th Ward of the City of Chicago.
 - 12. The parties rested on the results of the limited records examination.
- 13. The Hearing Officer has tendered to the Electoral Board a report and recommended decision. Based upon the evidence presented, the Hearing Officer found that the Candidate's Nomination Papers contained at least 971 signatures, which is more than the minimum number of valid signatures required by law to be placed upon the official ballot as a candidate for the office of Democratic Party Ward Committeeman for the 29th Ward of the City of Chicago, and that the Candidate's Nomination Papers should be found valid.
- 14. The Electoral Board, having considered the evidence and arguments tendered by the parties and the Hearing Officer's report of recommended findings and conclusions of law, hereby adopts the Hearing Officer's recommended findings and conclusions of law.
- 15. The Electoral Board finds that the Candidate has a sufficient number of valid signatures on his Nomination Papers to be placed upon the ballot as a candidate for the office of Democratic Party Ward Committeeman for the 29th Ward of the City of Chicago.
- 16. The Electoral Board further finds that the Candidate's Nomination Papers are valid.

IT IS THEREFORE ORDERED that the Objections of La Shawn K. Ford to the Nomination Papers of Christopher Taliaferro, candidate for the office of Democratic Party Ward

Committeeman for the 29th Ward of the City of Chicago, are hereby OVERRULED and said

Nomination Papers are hereby declared VALID and the name of Christopher Taliaferro,

candidate for the office of Democratic Party Ward Committeeman for the 29th Ward of the City

of Chicago, SHALL be printed on the ballot for the General Primary Election to be held on

March 15, 2016.
