FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of Board of Election Commissioners for the City of Chicago, Commissioners Marisel A. Hernandez, William J. Kresse and Jonathan T. Swain, organized by law in response to a Call issued by Marisel A. Hernandez, Chairwoman of said Electoral Board, for the purpose of hearing and passing upon objections (“Objections”) of Selena Evangeline Arreguin and Christian Sandoval (“Objectors”) to the nomination papers (“Nomination Papers”) of Neli Vazquez Rowland, candidate for the nomination of the Democratic Party for the office of Representative in Congress for the 4th Congressional District of the State of Illinois (“Candidate”) at the General Primary Election to be held on Tuesday, March 20, 2018, having convened on Monday, December 18, 2017 at 9:00 a.m., in Room 800, 69 West Washington Street, Chicago, Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate herein were duly and timely filed.

2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.

3. A Call to the hearing on said Objections was duly issued by the Chairwoman of the Electoral Board and served upon the members of the Electoral Board, the Objectors and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.

4. A public hearing held on these Objections commenced on Monday, December 18, 2017 and was continued from time to time.


5. The Electoral Board assigned this matter to Hearing Officer Samuel Jones for further hearings and proceedings.

6. The Objectors and the Candidate were directed by the Electoral Board's Call served upon them to appear before the Hearing Officer on the date and at the time designated in the Hearing Schedule. The following persons, among others, were present at such hearing: the Objectors, Selena Evangeline Arreguin and Christian Sandoval, by Attorney Michael Kreloff; and the Candidate, Neli Vazquez Rowland, by Attorney Luke J. Keller.



The Electoral Board finds that on Monday, December 11, 2017, the Candidate filed papers with the election authority with whom the original nomination papers were filed withdrawing as a candidate for election and requesting that her name not be printed upon the ballot, thus rendering the Objections moot.

IT IS THEREFORE ORDERED that the name of Neli Vazquez Rowland, candidate for the nomination of the Democratic Party for the office of Representative in Congress for the 4th Congressional District of the State of Illinois, SHALL NOT be printed on the official ballot for the General Primary Election to be held on Tuesday, March 20, 2018.


