## FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of the Board of Election Commissioners for the City of Chicago, Commissioners Marisel A. Hernandez, William J. Kresse and Jonathan T. Swain, organized by law in response to a Call issued by Marisel A. Hernandez, Chair of said Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of YOLANDA L. HOSKINS ("Objector") to the nomination papers ("Nomination Papers") of DWAYNE TRUSS, candidate for the office of Alderman for the 29th Ward of the City of Chicago ("Candidate") at the General Municipal Election to be held on Tuesday, February 26, 2019, having convened on Monday, December 10, 2018, at 8:30 a.m., in Room 800, 69 West Washington Street, Chicago, Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

- 1. Objections to the Nomination Papers of the Candidate were duly and timely filed.
- 2. The Electoral Board was legally constituted under the laws of the State of Illinois.
- 3. A Call to the hearing on said Objections was duly issued by the Chair of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.

- A public hearing held on these Objections commenced on Monday, December 10,
   2018 and was continued from time to time.
- 5. The Electoral Board assigned this matter to Hearing Officer Martin Greene for further hearings and proceedings.
- 6. The Objector and the Candidate were directed by the Electoral Board's Call served upon them to appear before the Hearing Officer on the date and at the time designated in the Hearing Schedule. By the date of the first hearing, the Objector had not been served but was served by the date of the subsequently scheduled hearing. The following persons, among others, were present at such hearing: the Objector, YOLANDA L. HOSKINS, and/or her Attorney ANDREW FINKO; the Candidate, DWAYNE TRUSS, and/or his Attorney ED MULLEN.
- 7. The Hearing Officer has tendered to the Electoral Board his report and recommended decision. The Hearing Officer recommends that the Objections to the Candidate's Nomination Papers be overruled and that the Nomination Papers be declared valid.
- 8. The Electoral Board, having reviewed the record of proceedings in this matter and having considered the report and recommendations of the Hearing Officer, as well as all argument and evidence submitted by the parties, hereby adopts the Hearing Officer's recommended findings and conclusions of law. A copy of the Hearing Officer's Final Report and Recommended Decision is attached hereto and is incorporated herein as part of the decision of the Electoral Board.
- 9. For the reasons stated above, the Electoral Board overrules the Objections to the Candidate's Nomination Papers and finds that the Candidate's Nomination Papers are valid.

10. The Electoral Board further finds that objections to the Candidate's Nomination

Papers were filed in related case(s) Rel.: 19-EB-ALD-020, 19-EB-ALD-071 and the Candidate's

Nomination Papers were deemed valid in each of those cases.

IT IS THEREFORE ORDERED that the Objections of YOLANDA L. HOSKINS to the Nomination Papers of DWAYNE TRUSS, candidate for the office of Alderman for the 29th Ward of the City of Chicago, are hereby OVERRULED and said Nomination Papers are hereby declared VALID and the name of DWAYNE TRUSS, candidate for the office of Alderman for the 29th Ward of the City of Chicago, SHALL be printed on the official ballot for the General Municipal Election to be held on Tuesday, February 26, 2019.

## HEARING OFFICER'S FINAL REPORT AND RECOMMENDED DECISIONS

In the matter of Petitioner-Objector, Yolanda L. Hoskins ("Objector") regarding the Nomination Papers of Respondent-Candidate, Dwayne Truss, for the nomination for the Office of Alderman, 29<sup>th</sup> Ward of the City of Chicago, State of Illinois ("Candidate") to be voted upon during the upcoming Municipal General Election on February 26, 2019 (election), the hearing having convened on December 10, 2018, Martin P. Greene, Esq., the duly appointed Hearing Officer, hereby makes the following Final Report and Recommended Decisions to the Board of Election Commissioners of the City of Chicago ("CBEC" or the "Board"):

Objector filed a Verified Objector's Petition objecting to the sufficiency of the Candidate's nomination papers for various reasons stated primarily in Paragraphs 5 to 11 of her Petition, to wit:

- 5. "Signer Not Registered at Address Shown..."
- 6. "Signer's Signature Not Genuine..."
- 7. "Signer Address Missing or Incomplete..."
- 8. "Signer's Petition More Than Once at Sheets/Line Indicated..."
- 9. "Nomination Papers Contain Less Than 473 Validly Collected Signatures..."
- 11. Nomination Papers Failed To Include Circulator's Residents Address "...on Sheets 83, 84, 87, 88, 182, 183, 184, 193, 209, 223, 234, 250, 257, 220, 222, 248"

The Objector's Petition was filed on December 3, 2018. An initial status hearing took place on December 10, 2018. Counsel for the Candidate, Ed Mullen and/or Elizabeth Homsy were present and Ed Mullen filed an Appearance. The Objector did not appear. The Hearing was

scheduled for 9:45 a.m. and the matter was called for Hearing at approximately 9:55 a.m. The record reflects that the call for the Hearing was posted at the offices of the Chicago Board of Election Commissioners on or about December 5, 2018.

The Hearing Officer inquired of Counsel for the Candidate whether said Counsel had any communication with either the Objector or persons purporting to represent the Objector. Candidate's counsel responded in the negative. The Hearing Officer advised that he will prepare a report and recommendation to the Board of Election Commissioners recommending Objector be defaulted.

Counsel for the Candidate stated that in the event Objector is not defaulted and the matter is not dismissed, that the Candidate will ask for a consolidated records examination with two other matters currently pending, those being Samuel Lewing vs. Dwayne Truss, Case Number 19-EB-ALD-020 and Samuel Lewing vs. Dwayne Truss, Case Number 19-EB-ALD-071. In support of which Counsel for the Candidate stated that the three Objection Petitions are identical in the font of the documents, the relief requested, the signatures challenged and the notarization provided.

On December 9, 2018, at 10:43:05 a.m., a Petition Summary Report was generated relating to the subject Objections. That Petition Summary Report indicated that there were 721 unchallenged signatures and that the Candidate had 1817 signatures greater than the required minimum.

Subsequently it was leaned by the Hearing Officer that Objector was not served with the Call prior to the December 10, 2018 hearing. Accordingly a new status hearing was set for December 20, 2018. At that time Andrew Finko appeared on behalf of the Objector and indicated he would review the Petition Summary Report and later indicate to the Hearing Officer and Candidate's Counsel what he planned to do given the results.

On December 27, 2018, a further status hearing was held. At that time Objector's Counsel

conceded that it appeared there may not be sufficient unchallenged signatures to go forward with

the objections. The Hearing Officer indicated he would make his findings and recommendations

based upon the then current record.

RECOMMENDED DECISIONS

Because of the foregoing, the Hearing Officer hereby makes the following Recommended

Decisions for consideration by the Commissioners:

1. That according to the Petition Summary Report there were 721 unchallenged

signatures and, further, that the Candidate had 1817 signatures greater than the

required minimum of 473;

2. That if all of the objections were ruled in favor of Objector, the Candidate would

still have a sufficient number of signatures to appear on the ballot, and;

3. That the Respondent-Candidate's name SHOULD BE INCLUDED on the ballot

for the office of Alderman of the 29th Ward of the City of Chicago during the

upcoming election of February 26, 2019.
