OBJECTOR'S PETITION

Petitioner-Objector Sally Hamann ("Objector") hereby files this Objector's Petition pursuant to Article 10 of the Election Code and 10 ILCS 5/10-8 challenging the legal and factual sufficiency of the nomination papers of Respondent-Candidate Justin Tucker ("Candidate") for the position of Alderman of the 1st Ward of the City of Chicago, Illinois, and the validity of voter signatures contained therein, which are not in compliance with Illinois law, as follows:

1. Objector Sally Hamann resides at 2430 N. Artesian Ave., Chicago, Illinois 60647, and is a duly qualified, legal and registered voter at this same address within the 1st Ward of the City of Chicago, Illinois.

2. The Objector's interest in filing this objection is that of citizens and voters desirous of seeing to it that the election laws of Illinois governing the filing of election petitions are properly complied with, and that only duly qualified candidates for the office of Alderman of the 1st Ward of the City of Chicago shall appear on the ballot for the Municipal General Election on February 26, 2019.

3. Candidate filed a Statement of Candidacy and petition signatures seeking to be placed on the ballot for election to the position of Alderman of the 1st Ward of the City of Chicago ("Nomination Papers").

4. Pursuant to Illinois law, the Nomination Papers of Candidate shall contain at least 473 signatures of qualified electors of the 1st Ward of the City of Chicago, collected in the manner prescribed by law between August 28, 2018 and November 26, 2018.

5. Objectors state that the Nomination Papers filed by Candidate are insufficient in fact and law because Candidate failed to submit 473 petition signatures.

6. Objector requests a finding that the Nomination Papers are factually and legally insufficient with fewer signatures than required, such that the Electoral Board shall issue a decision that the name of Candidate not appear or be printed on the ballot for the February 26, 2019 Municipal General Election.

WHEREFORE, Objectors request the following: (a) a hearing on the objections set forth herein; (b) a determination that the Nomination Papers of Candidate are legally and factually insufficient; (c) a decision that the name of Candidate, "Justin Tucker", shall not be printed on the official ballot as a candidate for the position of Alderman of the 1st Ward of the City of Chicago, Illinois, for the February 26, 2019 Municipal General Election.





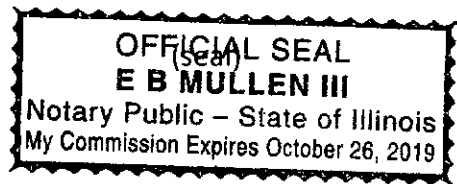
