VERIFIED OBJECTORS' PETITION

INTRODUCTION

Rogelio Varela and Michael E. Pollock, hereinafter sometimes referred to as the Objectors, state as follows:

- 1. The Objectors reside at 2633 North Drake Avenue, Chicago, Illinois, Zip Code 60647, in the Thirty-Fifth Ward of the City of Chicago, County of Cook, State of Illinois, and are both duly qualified, legal, and registered voters at that address.
- 2. The Objectors' interest in filing this Petition is that of voters desirous that he laws governing the filing of nomination papers for the office of Alderman of the Thirty-Fifth Ward of the City of Chicago, County of Cook, State of Illinois, are properly complied with and that only qualified candidates appear on the ballot for said office.

OBJECTIONS

3. The Objectors make the following objections to the purported nonintation papers ("Nomination Papers") of Mayra Gonzalez ("Candidate") as a candidate for election to the office of Alderman of the Thirty-Fifth Ward of the City of Chicago, County of Cook, State of Illinois ("Office") to be voted for at the Municipal General Election on February 26, 2019 ("Election"). Specifically, by this Verified Objectors' Petition objects to the filing made by Mayra Gonzalez at 2:46 PM on November 26, 2018, which consists of 69 petition sheets of voter signatures and nothing more. The same Objectors are simultaneously filing separate Verified Objectors' Petitions against the candidacy of Mayra Gonzalez generally and against the filing she made at 4:12 PM on November 26, 2018. The Objector states that the Nomination Papers are insufficient in fact and law for the following reasons:

- 4. Pursuant to State Law, nomination papers for the Office to be voted for at the Election must contain the signatures of not less than 473 duly qualified, registered, and legal voters of the Thirty-Fifth Ward of the City of Chicago, County of Cook, State of Illinois, collected in the manner prescribed by law. In addition, said Nomination Papers must truthfully allege the qualifications of the candidate, be gathered and presented in the manner provided for in the Illinois Election Code, and otherwise be executed in the form and manner required by law.
- 5. A candidate for the Office to be voted for at the Election must timely file with the Cook County Clerk a Statement of Economic Interests as required by the Illinois Governmental Ethics Act in relation to his candidacy. In violation of the Election Code, the Candidate has failed to file the required Statement of Economic Interests by the end of the period for the filing of nomination papers.
- 6. A candidate for the Office to be voted for at the Election must timely file with the Chicago Board of Election Commissioners a Receipt for their Statement of Economic Interests from the Cook County Clerk. Such receipt shall be so filed not later than the last day on which nomination papers may be filed. In violation of the Election Code, the Candidate has failed to file the required Receipt for her Statement of Economic Interests by the end of the period for the filing of nomination papers.
- 7. To wit, the Candidate has filed with the Chicago Board of Elections the incorrect Illinois Secretary of State Statement of Economic Interests form rather than the Cook County Clerk Statement of Economic Interests form as required by the Illinois Governmental Ethics Act. The Secretary of State form contains different questions and is incompatible with the County Clerk form. Further, the candidate did not file a Receipt for a Statement of Economic Interests as required by the Election Code but rather the original incorrect form. The Secretary of State form that the Candidate has filed is attached to this objection as Exhibit A.
- 8. A candidate for the Office to be voted for at the Election must include a statement of candidacy with her nominating petitions. In violation of the Election Code, The Candidate did not file a Statement of Candidacy with her petitions. The Receipt for the filing of her petitions indicating that no Statement of Candidacy was filed with her voter signature petition pages at 2:46 PM on November 26, 2018 is attached as Exhibit B.
- 9. The Candidate's Nomination Papers are legally and factually insufficient due to her failure to file with the Cook County Clerk a Statement of Economic Interests as required by the Illinois Governmental Ethics Act on or before November 26, 2018. The Candidate's Nomination Papers are legally and factually insufficient due to her failure to file with the Chicago Board of Election Commissioners a Receipt for a Statement of Economic Interests on or before November 26, 2018. The Candidate's Nomination Papers are legally and factually insufficient because she did not include a Statement of Candidacy together with her 69 voter signature petition sheets. The Candidate's filing of 2:46 PM on November 26, 2018 failed to comply with all three of these mandatory provisions of the Illinois Election Code. By the law of the State of Illinois and the precedent of this Electoral Board, the name of Mayra Gonzalez is not eligible to appear on the ballot for the Office at the Election.

WHEREFORE, the Objectors requests: a) a hearing on the objections set forth herein; b) an examination by the aforesaid Electoral Board of the official records relating to voters in the 35th Ward of the City of Chicago, County of Cook, State of Illinois, to the extent that such examination is pertinent to any of the matters alleged herein; c) a ruling that the Nomination Papers are insufficient in law and fact, and d) a ruling that the name of MAYRA GONZALEZ shall not appear and shall not be printed on the ballot for Election to the office of Alderman of the 35th Ward of the City of Chicago, County of Cook, State of Illinois, to be voted for at the Municipal General Election to be held on the 26th day of February, 2019.


