**FINDINGS AND DECISION**

The duly constituted Electoral Board, consisting of the Board of Election Commissioners for the City of Chicago, Commissioners Marisel A. Hernandez, William J. Kresse and Jonathan T. Swain, organized by law in response to a Call issued by Marisel A. Hernandez, Chair of said Electoral Board, for the purpose of hearing and passing upon objections (“Objections”) of ALAIN LAROSILIERE (“Objector”) to the nomination papers (“Nomination Papers”) of ELIZABETH SHYDLOWSKI, candidate for the office of Alderman of the 44th Ward of the City of Chicago (“Candidate”) at the General Municipal Election to be held on Tuesday, February 26, 2019, having convened on Monday, December 10, 2018, at 8:30 a.m., in Room 800, 69 West Washington Street, Chicago Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate were duly and timely filed.
2. The Electoral Board was legally constituted under the laws of the State of Illinois.

3. A Call to the hearing on said Objections was duly issued by the Chair of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.

4. A public hearing was held on these Objections commencing on Monday, December 10, 2018 and was continued from time to time.

5. The Electoral Board assigned this matter to Hearing Officer June Brown for further hearings and proceedings.

6. The Objector and the Candidate were directed by the Electoral Board to appear before the Hearing Officer on the date and at the time designated in the Call. The following persons, among others, were present at or filed appearances during such hearing; the Objector, ALAIN LAROSILIERE, and/or his Attorney, JAMES P. NALLY; and the Candidate, ELIZABETH SHYDLOWSKI, and/or her Attorney, JOHN FOGARTY JR.

7. The Hearing Officer ordered that an examination of the voter registration records be conducted by clerks and agents under the Board's direction and supervision, in accordance with the laws of Illinois and the rules of the Board.

8. The Hearing Officer directed all parties to appear and be present, either personally and/or by their authorized representatives during this records examination.

9. The Candidate and/or her duly authorized representative was present during the examination of the registration records.

10. The Objector and/or his duly authorized representative was present during the examination of the registration records.

11. The examination of the registration records was completed and the Electoral Board hereby adopts and incorporates by reference the results of the records examination

conducted by its clerks and agents. The written report of the result of the registration records examination is contained in the Board's file in this case and a copy has been provided or made available to the parties.

12. The results of the records examination indicate that:

A. The minimum number of valid signatures required by law for placement on the ballot for the office in question is 473.

B. The remaining number of signatures deemed valid as a result of the records examination total 487.

13. The Electoral Board finds that the number of valid signatures appearing on the Candidate's nominating petition following completion of the records examination exceeds the minimum number of valid signatures required by law to be placed upon the ballot as a candidate for the office of Alderman for the 44th Ward of the City of Chicago.

14. The Hearing Officer conducted a hearing to allow the Objector an opportunity to present evidence in support of his Rule 8 motion objecting to the Board's clerk's findings during the records examination, but the Objector rested on the results of the Rule 6 exam.

15. The Hearing Officer has tendered to the Electoral Board a report and recommended decision. Based upon the evidence presented, the Hearing Officer found that the Candidate's Nomination Papers contained 487 valid signatures, which exceeds the minimum number of valid signatures required by law to be placed upon the ballot as a candidate for the office of Alderman for the 44th Ward of the City of Chicago, and that the Candidate's Nomination Papers should be found valid.

16. The Electoral Board, having considered the evidence and arguments tendered by the parties and the Hearing Officer's report of recommended findings and conclusions of law, hereby adopts the Hearing Officer's recommended findings and conclusions of law.

17. For the reasons stated above, the Electoral Board finds that the Candidate has a sufficient number of valid signatures on her nominating petitions and that the Nomination Papers of ELIZABETH SHYDLOWSKI are, therefore, valid.


IT IS THEREFORE ORDERED that the Objections of ALAIN LAROSILIERE to the Nomination Papers of ELIZABETH SHYDLOWSKI, candidate for the office of Alderman for the 44th Ward of the City of Chicago, are hereby OVERRULED and said Nomination Papers are hereby declared VALID and the name of ELIZABETH SHYDLOWSKI, candidate for the office of Alderman for the 44th Ward of the City of Chicago, SHALL be printed on the official ballot for the General Municipal Election to be held on Tuesday, February 26, 2019.



HEARING OFFICER'S REPORT AND RECOMMENDED DECISION

The above-named cause came to be heard before the duly constituted Electoral Board, consisting of Chicago Board of Election Commissioners ("CBOE"). Pursuant to section 10-10 of the Illinois Election Code (10 ILCS 5/10-10), and the Rules and Regulations of the Chicago Board of Election Commissioners ("CBOE"). The official appointment by the Chicago Board of Election Commissioners ("CBOE") to act in the above-designated matter, assigned June A. Brown on December 10, 2018 as that Hearing Officer for hearings and passing on Objectors Petitions at the Offices of the Chicago Board of Election Commissioners ("CBOE"). at 69 W. Washington Lower Level.

This Recommendation rests on the Records Examination results and the Hearing Officer finds and recommends as follows:

- The initial hearing on the Objector's Petition was called on December 10, 2018. The Objectors appeared by Counsel, **James Nally, LAW OFFICE OF JAMES NALLY**, and the Candidate appeared by Counsel, **James Fogarty, LAW OFFICE OF JAMES FOGARTY**.
- The Candidate filed Nomination Papers as a Candidate for Election to the Office of Alderman of the 44<sup>th</sup> Ward of the City of Chicago, County of Cook, State of Illinois.
- The Objections to the Nomination Papers of the Candidate herein were duly and timely filed.
- The Objectors alleged that the Candidate failed to file the minimum number of 473 duly qualified, registered and legal voters of said 44<sup>th</sup> Aldermanic Ward, collected in the manner prescribed by Law, required for this office.
- On December 10, 2018, the initial hearing, the file exhibits were read and admitted into the record, service was waived and the Rules of Procedure were introduced to parties. The timelines for Motions, Responses and Reply were set.
- On December 10, 2018, the parties were informed that the Matter was being scheduled for a Records Examination, with the parties to be notified of the date by the Electoral Board. The Rule 6 Records Examination Directive was submitted
- On December 19, 2018 at 8:45 a.m., the Records Examination was completed and is hereby adopted and incorporated by reference to the results of the records examination. The parties submitted timely Rule 8 to preserve objections to the Records Examination findings
- On December 19, 2018 a Status hearing was held, where the Objector's Counsel, **James Nally**, and the Candidate's Counsel, **James Fogarty**, both stated that the Rule 6 Records Examination was under review for discrepancies and hand writing expert review.

- The Matter was set for a Status Hearing on December 27, 2018
- On December 27, 2018 the parties requested time to fully review the findings of the FINAL review.
- The Matter was set for a Status Hearing of January 2, 2019
- The Objector's Counsel, **James Nally**, and the Candidate's Counsel, **James Fogarty**, were present
- On January 2, 2019, Objector's Counsel, **James Nally**, stated on the record that upon review of the FINAL Record Examination Report, the Objector fully accepts the findings of the Rule 6 Records Examination and did not choose to proceed further in this Matter.
- The Candidate's Counsel, **James Fogarty**, had no objections to the Rule 6 Records Examination results
- The Records Examinations reflects a finding that the required number of valid signatures for this office is 473.
- The FINAL Rule 6 Records Examination Report found that the Candidate, **ELIZABETH SHYDLOWSKI**, had 487 valid signatures in the petition filings.

The Hearing Officer, June A. Brown, has considered all evidence and arguments proffered by the parties, and finds the following:


**14 SIGNATURES GREATER THAN THE REQUIRED MINIMUM**

The Hearing Officer finds that the number of valid signatures appearing on the Candidate's nominating petition following completion of the records examination is *above* the minimum number of valid signatures required by law to be placed upon the official ballot as a **CANDIDATE** for the office of **ALDERMAN OF THE 44<sup>TH</sup> WARD, COUNTY OF COOK, CITY OF CHICAGO, STATE OF ILLINOIS.**

**RECOMMENDATION**

For the foregoing reasons, it is my recommendation that the Objections of **ALAIN LAROSILIERE**, to the Nomination Papers of **ELIZABETH SHYDLOWSKI** be **OVERRULED**, for this **MATTER** and the Objections in the related matter of **2019-EB-ALD-108** for **ELIZABETH SHYDLOWSKI, CANDIDATE** for the office of **ALDERMAN OF THE 44<sup>TH</sup> WARD, COUNTY OF COOK, CITY OF CHICAGO, STATE OF ILLINOIS** in the February 26, 2018 General Municipal Elections.
