## **VERIFIED OBJECTOR'S PETITION**

Henry Cervantes, hereafter "Objectors", state as follows:

- Henry Cervantes, 2933 W. 24<sup>th</sup> Blvd., Apt. 2, Chicago, Illinois, 60623, and is a duly qualified, legal and registered voter at that address, which lies within the 12<sup>th</sup> Ward of Chicago, Illinois.
- 2. The Objector's interest in filing this Petition is to ensure that the laws governing the filing of nomination papers for the office of Alderman of the City of Chicago are properly complied with, and that only qualified candidates appear on the ballot for said office.
- 3. The Objector makes objections to the nomination papers, hereafter Nomination Papers, of Martha Yerania Rangel, hereafter Respondent, as candidate for the office of Alderman of the twelfth (12) Ward of the City of Chicago, to be voted on at the general municipal election on February 26, 2019. The Objectors state that the Nomination Papers are insufficient in fact and law for the reasons stated below.
- 4. Pursuant to 65 ILCS 20/21-28(a) nomination papers for candidates for the office of Alderman of any ward in the City of Chicago, must contain at least 473 signatures from valid qualified voters that reside within the boundaries of that ward and in a manner prescribed by law. Additionally, said nomination papers must truthfully allege the qualifications of the candidate, be gathered and presented in a manner consistent with the Illinois Election Code. The Nomination Papers of Martha Yerainia Rangel, purport to contain a sufficient number of signatures from such voters and purport to have been collected in a manner consistent with the Illinois Election Code.

- 5. Upon information and belief and the Candidate's Receipt for Nomination Papers, the Nomination Papers were not singularly bound in violation of 10 ILCS 5/7-10 and Barnes v. Smith, 95-EB-MUN-15 (1995).
- 6. The Candidate did not file a statement of economic interest with the City of Chicago, only with the County of Cook, in violation of the Illinois Election Code and the Municipal Code for the City of Chicago.
- 7. The Nomination Papers contain petition sheets with the names of persons who did not sign said papers in a manner consistent with the signature registered with the Board of Elections, and therefore are not genuine and/or are forgeries, as is set forth in the Appendix-Recapitulation attached to this Petition as Exhibit A, under Column A, under the heading, "Signature not genuine of purported voter," in violation of the Illinois Election Code.
- 8. The Nomination Papers contain petition sheets with the names of persons who are not registered voters at the addresses shown next to their names, as is set forth in the Appendix-Recapitulation attached to this Petition as Exhibit A, under Column B, under the heading, "Signer not registered at address shown," in violation of the Illinois Election Code.
- 9. The Nomination Papers contain petition sheets with the names of persons who do not reside within the 12<sup>th</sup> Ward of the City of Chicago, as is set forth in the Appendix-Recapitulation attached to this Petition as Exhibit A, under Column C, under the heading, "Signer Resides Outside of District," in violation of the Illinois Election Code.
- 10. The Nomination Papers contain petition sheets with the names of persons for whom the addresses stated missing, incomplete or illegible, as is set forth in the Appendix-Recapitulation attached to this Petition as Exhibit A, under Column D, under the heading, "Signer's Address Missing or Incomplete", in violation of the Illinois Election Code.
- 11. The Nomination Papers contain petition sheets with the names of persons for whom the signer signed the petition more than once, as is set forth in the Appendix-Recapitulation attached to this Petition as Exhibit A, under Column E, under the heading, "Signer Signed Petition More Than Once", in violation of the Illinois Election Code.
- 12. The Nomination Papers contain petition sheets with the names of persons for whom the signer signed the petition of Candidate Jose Rico before the petition of Martha Yerania Rangel, as is set forth in the Appendix-Recapitulation attached to this Petition as Exhibit A, under Column F, under the heading, "Signer Signed other candidate's sheet first, Sheet/Line", in violation of the Illinois Election Code.
- 13. The Nomination Papers contain petition sheets circulated by persons (circulators) whose sheets contain an affidavit where the Circulator certifies and swears to false assertions of signers being registered and signatures being genuine and demonstrate a pattern of fraud and disregard of the Illinois Election Code to such a degree that each sheet circulated by

each such Circulator is invalid, and should be stricken in their entirety as invalid. Such petitions are: sheet no.'s 62-70.

- 14. Exhibit A is an Appendix-Recapitulation and reference the Nomination Papers. An "X" placed on a line in a column indicates that the Objector is objecting to that particular signature for the corresponding reason listed in the column.
- 15. Based on the above listed irregularities and insufficiencies, the Nomination Papers are invalid in their entirety.

WHEREFORE, the Objectors request a hearing on the objections set forth herein, an examination by the aforesaid Electoral Board of the official records relating to voters in the applicable district, to the extent that examination is needed for any other matters alleged, a ruling that the nomination papers are insufficient in fact and law, and a ruling that the name Martha Yerania Rangel shall not appear and not be printed on the ballot for the office of Alderman of the twelfth (12<sup>th</sup>) ward, of the City of Chicago, Illinois, for the municipal election to be held on February 26, 2019.
