## **OBJECTIONS**

The Objector makes the following objections to the purported "Nomination Petitions" of CLARENCE DAVIDSON (Candidate) for 7th ward Alderman to be voted at the February 26th, 2019 Chicago municipal election (Election). The Objector states the Nomination Petitions are insufficient in fact and in law for the following reasons:

## A. FAILURE TO FILE A RECEIPT OF STATEMENT OF ECONOMIC INTEREST

The failure to file with the election authority with which nomination papers are to be filed a receipt evidencing that the candidate filed a Statement of Economic Interests with the appropriate official invalidates the nomination papers (10 ILCS 5/7-12) (from Ch. 46, par. 7-12)(8).

- 1. The candidate filed a Statement of Economic Interest to be filed with the Illinois Secretary of State.
- 2. The candidate failed to properly file a statement of economic interest and it's receipt with the proper authorities.

WHEREFORE, Objector, Jedidiah Brown, respectfully requests that the Candidates Nomination Petition deemed insufficient and the Candidates name not appear on the February 26th, 2018 ballot.
