VERIFIED OBJECTOR'S PETITION

NOW COMES, Kevin Bailey hereinafter referred to as the "Objector," and respectfully represents that Objector resides at 5944 South Calumet, in the City of Chicago, Illinois 60637.

Alderman of the 20th of the City of Chicago of the State of Illinois; that Objector is a duly qualified, registered and legal voter at such address; that Objector's interest in filing the following objections is that of a citizen desirous of seeing to it that the laws governing the filing of nomination papers for election of the office of Alderman of the 20th Ward of the City of Chicago in the State of Illinois are properly complied with and that only qualified candidates have their names appear on the ballot as candidates for the said office; and therefore Kevin Bailey, makes the following objections to the nomination papers of Sheila R. Scott as a "Candidate" for election of the office of Alderman of the 20th Ward of the City of Chicago in the State of Illinois, and files the same herewith, and states that the said nomination papers are insufficient in law and in fact for the following reasons:

CANDIDATE SCOTT PETITIONS VIOLATES THE STATUTES

1. Candidate Scott upon filing her petitions for candidacy for the Office of Alderman of the 20th ward failed to file a statement of economic interests and and failed to attached a receipt to his nominating petitions indicating he had complied with the requirement to file a statement of economic interests.

WHEREFORE, Kevin Bailey prays that the purported nomination papers of Sheila R. Scott as a candidate for nomination papers for election of the office of Alderman of the 20th Ward of the City of Chicago in the State of Illinois be declared by this Honorable Electoral Board to be insufficient and declare that the name of Sheila R. Scott as a candidate for election of the office of Alderman of the 20th Ward of the City of Chicago in the State of Illinois BE NOT PRINTED on the OFFICIAL BALLOT for the Primary Election to be held on February 26, 2019.



CANDIDATE SCOTT'S PETITIONS VIOLATES THE STATUTES

2. Kevin Bailey states that the signatures of not less than 473 duly qualified, registered, and legal voters of the 20th Ward of the City of Chicago in the State of Illinois, are required.
3. Kevin Bailey states that Sheila R. Scott has filed 1 petition signature sheets containing a maximum total of 20 signatures of allegedly duly qualified, legal, and registered voters of the 20th Ward of the City of Chicago in the State of Illinois.
4. Kevin Bailey states that the nomination papers herein contested consisted of various sheets supposedly containing valid and legal signatures of 980 individuals. The individual objections cited herein with specificity reduce the number of valid signatures below the statutory minimum of 473.


