

WHEREFORE, the Objector requests: a) a hearing on the objections set forth herein; b) an examination by the aforesaid Electoral Board of the official records relating to voters in the City of Chicago, to the extent that such examination is pertinent to any of the matters alleged herein; c) a ruling that the Nomination Papers are insufficient in law and fact, and d) a ruling that the name of **Anna M Valencia** shall not appear and not be printed on the ballot for nomination to the office of City Clerk of the City of Chicago, to be voted for at the Municipal General Election to be held February 26, 2019.



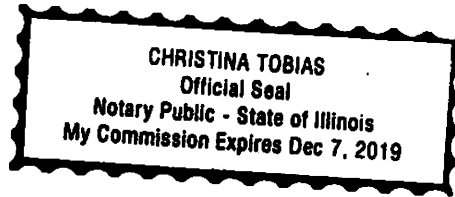
