**DECISION**

The duly constituted Electoral Board, consisting of MICHAEL J. HAMBLET, ARNETTE R. HUBBARD and CHRISTOPHER ROBLING, organized by law in response to a Call issued by MICHAEL J. HAMBLET, Chairman of said Electoral Board, for the purpose of hearing and passing upon Objections to Nominating Petitions for the Office of State Senator and Representative in the General Assembly for the State of Illinois, having convened on February 7th, 1992 at 12:00 p.m. in the City Council Chambers, City Hall, Chicago, Illinois; and having heard and determined the objections to the petition in the above entitled matter find that:

1. The said Electoral Board has been legally constituted according to the laws of the State of Illinois;
2. Objections to the nominating petition of the candidate herein were duly filed;
3. A call to the hearing on said objections was duly issued and was served upon the members of the Electoral Board, the Objector and the Candidate by mail and by personal service as provided by statute;
4. A public hearing was held on these objections commencing on February 7, 1992;
5. The following persons, among others, were present at such hearings: the members of the Electoral Board, the Objector by counsel and the Candidate by counsel;

6. The Board finds that the Candidate has withdrawn his nomination papers.

**IT IS THEREFORE ORDERED** that the name of Robert N. Oberg, candidate for nomination to the office of State Senator of the 6th Legislative District, Republican Party, shall not be printed on the ballot for the Primary Elections to be held on March 17th, 1992.
