FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of Chicago Board of Election Commissioners Langdon D. Neal, Richard A. Cowen and Marisel A. Hernandez, organized by law in response to a Call issued by Langdon D. Neal, Chairman of said Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of KRISTOPHER J. ANDERSON ("Objector") to the nomination papers ("Nomination Papers") of DERRICK PRINCE, candidate for nomination of the Democratic Party to the office of Representative in the General Assembly for the 32nd District, State of Illinois ("Candidate"), having convened on November 20, 2007, at 10:00 a.m., at 69 W. Washington Street, 8th Floor Conference Room, Chicago, Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate herein were duly and timely filed.

- 2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.
- 3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.
- A public hearing held on these Objections commenced on November 20,
 and was continued from time to time.
- The Electoral Board assigned this matter to Hearing Examiner Casandra
 Watson for further hearings and proceedings.
- 6. The Objector and the Candidate were directed by the Electoral Board to appear before the Hearing Examiner for a hearing on the date and at the time designated on the Electoral Board's docket. The following persons, among others, were present at such hearing: the Objector, KRISTOPHER J. ANDERSON, appearing by counsel, Michael J. Kasper; and the Candidate, DERRICK PRINCE, appearing pro se.
- 7. The Candidate filed a motion to strike the Objector's Petition, arguing that it was a "shot gun" objection not based upon a reasonable investigation of facts.
- 8. The Hearing Examiner ordered that an examination of the registration records be conducted by clerks and agents under the Board's direction and supervision, in accordance with the laws of Illinois and the rules of the Board.
- 9. The Hearing Examiner directed all parties to appear and be present, either personally and/or by their authorized representatives during the records examination.

- 10. The Candidate or his duly authorized representative(s) was present during the examination of the registration records.
- 11. The Objector or his duly authorized representative(s) was present during the examination of the registration records.
- 12. The examination of the registration records was completed and the Electoral Board hereby adopts and incorporates by reference the results of the records examination conducted by its clerks and agents. The written report of the results of the registration records examination is contained in the Electoral Board's file in this case and is available for inspection upon request of a party.
- 13. The results of the records examination conducted in this matter indicate that:
 - A. The minimum number of valid signatures required by law for placement on the ballot for the office in question is 500;
 - B. The number of purportedly valid signatures appearing on the nominating petition filed by the Candidate total 2,356;
 - C. The number of signatures deemed invalid because of objections sustained total 1,820;
 - D. The remaining number of signatures deemed valid total 536.
- 14. Following completion of the records examination, the Hearing Examiner denied the Candidate's motion to strike and dismiss the Objector's Petition, finding that the Candidate's motion was without merit inasmuch as a review of the records examination indicate that approximately seventy-seven percent (77%) of the Objections were sustained during the records examination.

- 15. Both parties filed Rule 8 statements seeking to present evidence. The Hearing Examiner conducted a series of evidentiary hearings. After considering all of the evidence and argument from both sides, the Hearing Examiner concluded that the Candidate's nominating petition sheets contain only 488 valid signatures, short of the 500 minimum signatures required by law.
- 16. The Hearing Examiner has tendered to the Electoral Board her report and recommended decision. The Hearing Examiner recommends that the Objections to the Candidate's Nomination Papers be sustained and that the Nomination Papers be found invalid.
- 17. The Electoral Board, having reviewed the record of proceedings in this matter and having considered the report and recommendations of the Hearing Examiner, as well as all argument and evidence submitted by the parties, hereby adopts the Hearing Examiner's recommended findings and conclusions of law. A copy of the Hearing Examiner's Report and Recommended Decision is attached hereto and is incorporated herein as part of the decision of the Electoral Board.
- 18. The Electoral Board finds that the objections to signatures listed on certain sheets and lines of the Objector's Petition are sustained in part and overruled in part as more fully indicated in the results of the records examination.
- 19. The Electoral Board finds that the number of valid signatures appearing on the Candidate's nominating petition is fewer than the minimum number of valid signatures required by law to be placed upon the official ballot as a candidate for nomination of the Democratic Party to the office of Representative in the General Assembly for the 32nd District, State of Illinois.

20. For the reasons stated above, the Electoral Board sustains the Objections to the Candidate's Nomination Papers and finds that the Candidate's Nomination Papers are invalid.

IT IS THEREFORE ORDERED that the Objections of KRISTOPHER J. ANDERSON to the Nomination Papers of DERRICK PRINCE, candidate for nomination of the Democratic Party to the office of Representative in the General Assembly for the 32nd Representative District, State of Illinois, are hereby SUSTAINED and said Nomination Papers are hereby declared INVALID and the name of DERRICK PRINCE, candidate for nomination of the Democratic Party to the office of Representative in the General Assembly for the 32nd Representative District, State of Illinois, SHALL NOT be printed on the official ballot for the General Primary Election to be held on February 5, 2008.

HEARING EXAMINER'S RECOMMENDED DECISION

This matter appearing on call for the first time on November 20,2007 at 1:00 P.M.; the Petitioner-Objector being represented by Atty. Michael Kasper (Atty. Raucci appearing) and the Respondent-Candidate appearing pro se; the Respondent-Candidate filing his Motion to Strike and Dismiss instanter. At the request of counsel for the petitioner-objector a review of the Motion to Strike and Dismiss was completed by this hearing examiner and a records examination was ordered and scheduled at that time. This matter was continued to November 27, 2007 at 1:00 P.M. for hearing on all Motions to Strike and Dismiss timely filed. Thereafter the following pleadings were timely filed:

- 1. Petitioner-Objector's Response to the Motion to Strike and Dismiss
- 2. Respondent-Candidate's Response to Motion to Strike and Dismiss

On November 27, 2007 this matter appeared on call for the second time for hearing on all motions commencing at 1:35 P.M. Respondent-Candidate appearing Pro se and Atty. Michael Kasper appearing on behalf of the Petitioner-Objector. The records examination ordered on November 20, 2007 had not been completed and the parties proceeded to hearing on Respondent-Candidate's Motion to Strike and Dismiss.

After argument by both parties this matter was continued to November 30, 2007 for the results of the record examination. No decision was rendered on the record re: Motion to Strike and Dismiss.

On November 30, 2007, this matter appeared on call for the third time, commencing at 1:05 P.M. Atty. Kasper appeared on behalf of the objector and Derrick Prince appeared pro se. The records examination having been completed on November 28, 2007, the following results were spread of record:

Number of Signature on Petitions: 2, 356
Number of Objections overruled: 260
Number of Objections sustained: 1,820
Number of Valid Signatures: 536
Minimum Signature Requirement: 500

Upon inquiry by this hearing examiner, Atty. Kasper indicated that he intended to file a Rule 8 Motion no later that Monday, December 3, 2007. Thereafter this matter was set at the convenience of Derrick Prince for Tuesday, December 4, 2007 at 2:00 P.M.

RECOMMENDED DECISION RE: MOTION TO STRIKE AND DISMISS Candidate's Motion to Strike and Dismiss is without merit. A review of the records examination indicates that approximately seventy-seven percent (77%) of the objector's objections were sustained. MOTION DENIED

On Monday, December 3, 2007 Atty. Kasper filed his Rule 8 Statement and accompanying six (6) pages. On December 4, 2007, at 1:41 P.M. (19 minutes b/4 the hearing on Rule 8 motions had been previously scheduled, Derrick Prince filed his Candidate's Rule 8 Statement and accompanying sixteen (16) pages. Additionally, both parties made formal requests to produce board records. (Mr. Prince's request was made during the hearing at 3:45 P.M. on December 4, 2007.

On December 4, 2007 at 2:30 P.M. this matter appeared on call for the fourth time for hearing on Mr. Kasper's Rule 8 Motion. Atty. Kasper appeared on behalf of the objector and Derrick Prince appeared pro se. Total Valid Signatures prior to the commencement of the Rule 8 Motion was 536.

Atty. Kasper advised that his Rule 8 evidence would be divided into three (3) categories; (1) mathematical errors; (2) objections made but not ruled upon during the records examination, and (3) objections overruled during the records exam. Thereafter the following evidence was adduced by Atty. Kasper:
