### FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of Chicago Board of Election
Commissioners Langdon D. Neal, Richard A. Cowen, and Marisel A. Hernandez,
organized by law in response to a Call issued by Langdon D. Neal, Chairman of said
Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of
AMY SUE MERTENS ("Objector") to the nomination papers ("Nomination Papers") of
JONATHAN SINGH BEDI, candidate for nomination of the Democratic Party to the
office of State Senator for the 5th Legislative District, State of Illinois ("Candidate"),
having convened on November 20, 2007, at 10:00 a.m., at 69 W. Washington Street, 8<sup>th</sup>
Floor Conference Room, Chicago, Illinois, and having heard and determined the
Objections to the Nomination Papers in the above-entitled matter, finds that:

- Objections to the Nomination Papers of the Candidate herein were duly and timely filed.
- 2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.

- 3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.
- A public hearing held on these Objections commenced on November 20,
   and was continued from time to time.
- The Electoral Board assigned this matter to Hearing Examiner Rodney W.
   Stewart for further hearings and proceedings.
- 6. The Objector and the Candidate were directed by the Electoral Board to appear before the Hearing Examiner for a hearing on the date and at the time designated on the Electoral Board's docket. The following persons, among others, were present at such hearing: the Objector, AMY SUE MERTENS, appearing by counsel, Richard K. Means; and the Candidate, JONATHAN SINGH BEDI, appearing by counsel, James P. Nally.
- 7. The Hearing Examiner ordered that an examination of the registration records be conducted by clerks and agents under the Board's direction and supervision, in accordance with the laws of Illinois and the rules of the Board.
- 8. The Hearing Examiner directed all parties to appear and be present, either personally and/or by their authorized representatives during the records examination.
- 9. The Candidate or his duly authorized representative(s) was present during the examination of the registration records.
- 10. The Objector or her duly authorized representative(s) was present during the examination of the registration records.

11. The examination of the registration records was completed and the Electoral Board hereby adopts and incorporates by reference the results of the records examination conducted by its clerks and agents. The written report of the results of the registration records examination is contained in the Electoral Board's file in this case and is available for inspection upon request of a party.

### 12. The Electoral Board finds that:

- A. The minimum number of valid signatures required by law for placement on the ballot for the office in question is 1,000;
- B. The number of purportedly valid signatures appearing on the nominating petition filed by the Candidate total 3,444;
- C. The number of signatures deemed invalid because of objections sustained total 2,237;
- D. The remaining number of signatures deemed valid total 1,207.
- 13. The Electoral Board finds, therefore, that objections to signatures listed on certain sheets and lines of the Objector's Petition are sustained in part and overruled in part as more fully indicated in the results of the records examination.
- 14. The Electoral Board finds that the number of valid signatures appearing on the Candidate's nominating petition following completion of the records examination exceeds the minimum number of valid signatures required by law to be placed upon the official ballot as a candidate for nomination of the Democratic Party to the office of State Senator for the 5th Legislative District, State of Illinois.
- 15. For the reasons stated above, the Electoral Board overrules the Objections and finds that the Nomination Papers of JONATHAN SINGH BEDI are valid.

16. The Electoral Board further finds that additional objections were filed against the Candidate's Nomination Papers in case number 08-EB-SS-08 but that the objections in that case were withdrawn.

IT IS THEREFORE ORDERED that the Objections of AMY SUE MERTENS to the Nomination papers of JONATHAN SINGH BEDI, candidate for nomination of the Democratic Party, to the office of State Senator for the 5th Legislative District, State of Illinois, are hereby OVERRULED and said Nomination Papers are hereby declared VALID and the name of JONATHAN SINGH BEDI, candidate for nomination of the Democratic Party, to the office of State Senator for the 5th Legislative District, State of Illinois, SHALL be printed on the official ballot for the General Primary Election to be held on February 5, 2008.

Hearing Examiner's Recommended Findings

The matter was first called for the initial hearing on November 21, 2007. Service was determined to be proper and all parties are represented by their respective legal counsel and Appearances have been filed and exchanged. The Candidate is represented by attorney James Nally. The Objector is represented by attorney Richard Means. The Candidate filed a Motion to Strike and the Objector filed a Response. The Candidate filed a Reply. A directive was executed seeking a Records Examination.

The matter was continued to November 27, 2007 for hearing on the Candidate's Motion to Strike. The Motion to Strike was denied. The matter was continued to December 5, 2007 and again to December 7, 2007 and December 11, 2007 for Status with respect to the Records Examination results. Record Examination results were obtained on December 11, 2007 and the results revealed that the Candidate had 1247 valid signatures.

The Objector filed a motion pursuant to Rule 8 of the Rules of Procedure For The Board of Election commissioners of the City of Chicago. The Candidate filed a motion pursuant to Rule 8 of the Rules of Procedure. The matter was continued to December 14, 2007 for hearing on the motions.

Hearings of all motions were conducted on December 14, 2007. The Candidate is required to have a minimum of 1000 valid signatures to be placed on the ballot in the upcoming primary. The Objector did not put forth any evidence pursuant to her Rule 8 motion and rested based upon the results of the Records Examination. The Candidate was not required to put forth any evidence and did not.

It is the recommendation of the Hearing Officer that Jonathan Singh Bedi's name be placed on the ballot as candidate for the office of State Senator of the State of Illinois for the 5th Legislative District in the upcoming primary on February 5, 2008.
