FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of Chicago Board of Election Commissioners Langdon D. Neal, Richard A. Cowen, and Marisel A. Hernandez, organized by law in response to a Call issued by Langdon D. Neal, Chairman of said Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of RICKEY R. HENDON and BERNETTE A. BARNES ("Objectors") to the nomination papers ("Nomination Papers") of JONATHAN SINGH BEDI, candidate for the nomination of the Democratic Party to the office of State Senator for the 5th Legislative District, State of Illinois ("Candidate"), having convened on November 20, 2007, at 10:00 a.m., at 69 W. Washington Street, 8th Floor Conference Room, Chicago, Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate herein were duly and timely filed.

2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.

3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objectors and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.

4. A public hearing held on these Objections commenced on November 20, 2007 and was continued from time to time.

5. The Electoral Board assigned this matter to Hearing Examiner Rodney Stewart for further hearings and proceedings.


6. The Objectors and the Candidate were directed by the Electoral Board to appear before the Hearing Examiner for a hearing on the date and at the time designated on the Electoral Board's docket. The following persons, among others, were present at such hearing: the Objectors, RICKEY R. HENDON and BERNETTE A. BARNES; appearing by counsel, Michael C. Dorf; and the Candidate, JONATHAN SINGH BEDI appearing by counsel, Shawna M. Doran.

7. The Electoral Board finds that the Objectors filed a motion on December 4, 2007 to withdraw their Objections against the Candidate's Nomination Papers.


8. The Electoral Board further finds that there is another objection filed against the Candidate's Nomination Papers in case 08-EB-SS-07 and that such objections are still pending. The outcome of those objections will determine whether the Candidate's Nomination Papers are valid or invalid.

IT IS THEREFORE ORDERED that the motion of the OBJECTORS RICKEY R. HENDON and BERNETTE A. BARNES to withdraw their OBJECTIONS to the Nomination Paper of JONATHAN SINGH BEDI, candidate for nomination of the Democratic Party to the office of State Senator for the 5th Legislative District, State of Illinois, is hereby GRANTED and said OBJECTIONS are WITHDRAWN.


