FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of Chicago Board of Election
Commissioners Langdon D. Neal, Richard A. Cowen, and Marisel A. Hernandez,
organized by law in response to a Call issued by Langdon D. Neal, Chairman of said
Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of
Anthony Buehring ("Objector") to the nomination papers ("Nomination Papers") of Jose
"Joe" Massas, candidate for nomination of the Democratic Party for the office of
Representative in the General Assembly, 4th Representative District, State of Illinois
("Candidate"), having convened on November 16, 2009, at 10:00 a.m., at 69 W.
Washington Street, 8th Floor Conference Room, Chicago, Illinois, and having heard and
determined the Objections to the Nomination Papers in the above-entitled matter, finds
that:

- 1. Objections to the Nomination Papers of the Candidate herein were duly and timely filed.
- 2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.
- 3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.
- A public hearing held on these Objections commenced on November 16,
 2009 and was continued from time to time.
- 5. The Electoral Board assigned this matter to Hearing Officer Edwin Reyes for further hearings and proceedings.
- 6. The Objector and the Candidate were directed by the Electoral Board to appear before the Hearing Officer for a hearing on the date and at the time designated on the Electoral Board's Initial Hearing Schedule. The following persons, among others, were present at such hearing: the Objector, Anthony Buehring, appearing by counsel, Michael J. Kasper; and the Candidate, Jose "Joe" Massas, appearing by counsel, Richard K. Means.
- 7. The Hearing Officer ordered that an examination of the registration records be conducted by clerks and agents under the Board's direction and supervision, in accordance with the laws of Illinois and the rules of the Board.
- 8. The Hearing Officer directed all parties to appear and be present, either personally and/or by their authorized representatives during the records examination.

- 9. The Candidate or his duly authorized representative(s) were present during the examination of the registration records.
- 10. The Objector or his duly authorized representative(s) were present during the examination of the registration records.
- 11. The examination of the registration records of the Board was terminated on November 22, 2009 after 84 petition sheets had been examined and it was determined that the Candidate had a minimum of at least 599 valid signatures on his Nomination Papers, in excess of the statutory minimum of 500 signatures.
- 12. The Objector withdrew his objections concerning the Candidate's receipt for his Statement of Economic Interests.
- 13. The Electoral Board has considered all evidence and arguments tendered by the parties, as well as the report and recommended findings and conclusions of law of the Hearing Officer.
- 14. The Electoral Board finds that the number of valid signatures appearing on the Candidate's nominating petition exceeds the minimum number of valid signatures required by law to be placed upon the official ballot as a candidate for nomination of the Democratic Party for the office of Representative in the General Assembly, 4th Representative District, State of Illinois.
- 15. The Electoral Board finds, therefore, that the Objections are overruled and that the Nomination Papers of Jose "Joe" Massas are valid.

IT IS THEREFORE ORDERED that the Objections of Anthony Buehring to the Nomination Papers of Jose "Joe" Massas, candidate for nomination of the Democratic Party for the office of Representative in the General Assembly, 4th Representative District, State of Illinois, are hereby OVERRULED and said Nomination Papers are hereby declared VALID and the name of Jose "Joe" Massas, candidate for nomination of the Democratic Party for the office of Representative in the General Assembly, 4th Representative District, State of Illinois, SHALL be printed on the official ballot for the
