## BOARD OF ELECTION COMMISSIONERS FOR THE CITY OF CHICAGO AS A DULY CONSTITUTED ELECTORAL BOARD

## FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of Board of Election Commissioners for the City of Chicago Commissioners Langdon D. Neal, Richard A. Cowen, and Marisel A. Hernandez, organized by law in response to a Call issued by Langdon D. Neal, Chairman of said Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of Bessie Luckett ("Objector") to resolution to fill a vacancy in nomination and the nomination papers ("Nomination Papers") of Lynn Renee Franco, candidate for the nomination of the Republican Party for the office of Representative in the General Assembly for the 33rd Representative District in the State of Illinois ("Candidate") at the General Election to be held on November 4, 2014, having convened on June 13, 2014 at 9:00 a.m., in Room 800, 69 West Washington Street, Chicago, Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

1. Objections to the Nomination Papers of the Candidate herein were duly and timely filed.

- 2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.
- 3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.
- 4. A public hearing held on these Objections commenced on June 13, 2014 and was continued from time to time.
- 5. The Electoral Board assigned this matter to Hearing Officer Lynne R. Ostfeld for further hearings and proceedings.
- 6. The Objector and the Candidate were directed by the Electoral Board to appear before the Hearing Officer on the date and at the time designated in the Hearing Schedule. The following persons, among others, were present at such hearing: the Objector, Bessie Luckett, by her attorney, Michael Kasper; and the Candidate, Lynn Renee Franco, by her attorney, John Fogarty.
- 7. The Hearing Officer ordered that an examination of the voter registration records be conducted by clerks and agents under the Board's direction and supervision, in accordance with the laws of Illinois and the rules of the Board.
- 8. The Hearing Officer directed all parties to appear and be present, either personally and/or by their authorized representatives, during this records examination.
- 9. The Candidate and/or her duly authorized representative was present during the examination of the registration records.
- 10. The Objector and/or her duly authorized representative was present during the examination of the registration records.

- 11. The examination of the registration records was completed and the Electoral Board hereby adopts and incorporates by reference the results of the records examination conducted by its clerks and agents. The written report of the result of the registration records examination is contained in the Electoral Board's file in this case and a copy has been provided or made available to the parties.
  - 12. The results of the records examination indicate that:
    - A. The minimum number of valid signatures required by law for placement on the ballot for the office in question is 500;
    - B. The number of purportedly valid signatures appearing on the nominating petition filed by the Candidate total 925;
    - C. The number of signatures deemed invalid because of objections sustained as a result of the records examination total 559;
    - D. The remaining number of signatures deemed valid as a result of the records examination total 366.
- 13. The Electoral Board finds that the number of valid signatures appearing on the Candidate's nominating petition following completion of the records examination was less than the minimum number of valid signatures required by law to be placed upon the official ballot as a candidate for the nomination of the Republican Party for the office of Representative in the General Assembly for the 33rd Representative District of the State of Illinois.
- 14. No Rule 8 motions objecting to the Board's clerk's findings during the records examination were filed.
- 15. The Hearing Officer has tendered to the Electoral Board a report and recommended decision. Based upon the evidence presented, the Hearing Officer found that the

Candidate's Nomination Papers contained only 366 valid signatures, which is less than the minimum number of valid signatures required by law to be placed upon the official ballot as a candidate for nomination of the Republican Party for the office of Representative in the General Assembly for the 33rd Representative District of the State of Illinois, and that the Candidate's Nomination Papers should be found invalid.

- 16. The Electoral Board, having considered the evidence and arguments tendered by the parties and the Hearing Officer's report of recommended findings and conclusions of law, hereby adopts the Hearing Officer's recommended findings and conclusions of law.
- 17. For the reasons stated above, the Electoral Board finds that the Candidate has an insufficient number of valid signatures on her nominating petitions and that the Nomination Papers of Lynn Renee Franco are, therefore, invalid.

IT IS THEREFORE ORDERED that the Objections of Bessie Luckett to the resolution to fill a vacancy in nomination and the Nomination Papers of Lynn Renee Franco, candidate for the nomination of the Republican Party for election to the office of Representative in the General Assembly of the 33rd Representative District of the State of Illinois are hereby SUSTAINED and said Nomination Papers are hereby declared INVALID and the name of Lynn Renee Franco, candidate for nomination of the Republican Party for the office of Representative in the General Assembly for the 33rd Representative District of the State of Illinois, SHALL NOT be printed on the official ballot for the General Election to be held on November 4, 2014
