FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of the Board of the Election

Commissioners for the City of Chicago, Commissioners Marisel A. Hernandez, William J.

Kresse and June A. Brown, organized by law in response to a Call issued by Marisel A.

Hernandez, Chair of said Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of CLAUDIAIRUSS D. SITGRAVES, SR ("Objector") to the nomination papers ("Nomination Papers") of LAMONT RAYMOND WILLIAMS, candidate for the nomination of the Democratic Party for the office of State Senator, 16th Legislative District in the State of Illinois ("Candidate") at the General Primary Election to be held on Tuesday, June 28, 2022, having convened on March 28, 2022, at 9:00 a.m., in Room 800, 69 West Washington Street, Chicago Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

- 1. Objections to the Nomination Papers of the Candidate were duly and timely filed.
- 2. The Electoral Board was constituted according to the laws of the State of Illinois.

- 3. A Call to the hearing on said Objections was duly issued by the Chair of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute or service was waived.
- 4. A public hearing held on these Objections commenced on March 28, 2022 and was continued from time to time. The Electoral Board assigned this matter to Hearing Officer Joseph Morris for further hearings and proceedings.
- 5. The Objector and Candidate were directed by the Electoral Board's Call served upon them to appear before the Hearing Officer on the date and at the time designated in the Hearing Schedule. Appearances were filed by or on behalf of the following persons: The Objector, CLAUDIAIRUSS D. SITGRAVES, SR, Attorneys, BURTON S ODELSON and ROSS D. SECLER; and the Candidate, LAMONT RAYMOND WILLIAMS, Attorney, ED MULLEN.
- 6. The Electoral Board finds that on Thursday, April 7, 2022 the Objector filed a motion to withdraw Objections against the Candidate's Nomination Papers. The Electoral Board grants the Objector's motion to withdraw the Objections and the Objections are withdrawn.
- 7. The Electoral Board further finds that there are no additional Objections filed against the Candidate's Nomination Papers and, in the absence of any objections thereto, such Nomination Papers are deemed valid.

IT IS THEREFORE ORDERED that the Nomination Papers of LAMONT RAYMOND WILLIAMS, candidate for the nomination of the Democratic Party for the office of State Senator, 16th Legislative District in the State of Illinois, are deemed VALID and the name of the

Candidate SHALL be printed on the official ballot for the General Primary Election to be held on Tuesday, June 28, 2022.
