OBJECTOR'S PETITION TO THE NOMINATION PAPERS OF
CANDIDATE BYRON SIGCHO-LOPEZ
FOR ALDERMAN OF THE 25TH WARD, CITY OF CHICAGO

Objector's Name: HECTOR VILLAGRANA

Pursuant to applicable provisions of the Illinois Election Code at 10 ILCS 5/10-8, the objector hereby challenges the nominating papers of candidate Byron Sigcho-Lopez based on the following information:

1. Objector is a registered voter in the 25th Ward of the City of Chicago.
2. Objector desires to ensure that only qualified candidates appear on the ballot for the February 26, 2019 Municipal General Election.
3. On information and belief, the candidate's legal name is Byron Sigcho.
4. A review of circuit court records and other available information, the candidate has not legally changed his name to Byron Sigcho-Lopez and he is registered to vote as Byron Sigcho.
5. Petitions for the candidate in previous legal filings were filed as Byron Sigcho, and the filing of the petitions this election under the name of Byron Sigcho-Lopez taint the nomination process and require that the candidates name be stricken from the ballot.
6. By circulating and filing the petitions under the name Byron Sigcho-Lopez, the candidate creates confusion among the public, which requires that the candidate be stricken from the ballot.
7. By circulating and hyphenating the name Byron Sigcho-Lopez, the candidate has added a new surname. This has created confusion the community and requires that the candidate be stricken from the ballot.
8. Candidate Sigcho-Lopez has not previously used the hyphenated name before, except for the circulating of the petitions, and he has failed to inform the public of his real name in the statement of candidacy.





2. That he/she is a registered voter in the 25th Ward, City of Chicago, County of Cook, State of Illinois.

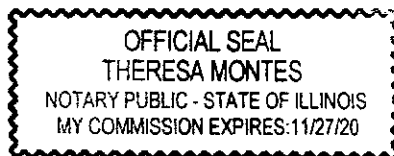
