**DECISION**

The duly constituted Electoral Board, consisting of MICHAEL J. HAMBLET, ARNETTE R. HUBBARD and RAYMOND L. JAGIELSKI, organized by law in response to a Call issued by MICHAEL J. HAMBLET, Chairman of said Electoral Board, for the purpose of hearing and passing upon Objections to Nominating Petitions for the Offices of Mayor, Clerk and Treasurer of the City of Chicago and Alderman in the City of Chicago, having convened on December 28th, 1990 at 10:00 a.m. in the City Council Chambers, City Hall, Chicago, Illinois; and having heard and determined the objections to the petition in the above entitled matter find that:


1. The said Electoral Board has been legally constituted according to the laws of the State of Illinois;
2. Objections to the nominating petition of the candidate herein were duly filed;
3. A call to the hearing on said objections was duly issued and was served upon the members of the Electoral Board, the Objector and the Candidate by mail and by personal service as provided by statute;
4. A public hearing was held on these objections commencing on December 28th, 1990;


5. The following persons, among others, were present at such hearings: the members of the Electoral Board, the Objector by counsel, and the Candidate pro se;
6. The Board finds that the Objector has withdrawn his objections.

**IT IS THEREFORE ORDERED** that the objections of Robert K. Anderson to the nominating petition of Brette X. New, candidate for nomination to the office of Mayor for the City of Chicago, Republican Party, are hereby dismissed and said petition is hereby declared valid and the name of Brette X. New, candidate for nomination to the office of Mayor for the City of Chicago, shall be printed on the ballot for the Municipal Primary Election to be held on February 26th, 1991.
