DECISION

The duly constituted Electoral Board, consisting of MICHAEL J. HAMBLET, ARNETTE R. HUBBARD, and RICHARD A. COWEN, organized by law in response to a Call issued by MICHAEL J. HAMBLET, Chairman of said Electoral Board, for the purpose of hearing and passing upon Objections to Independent Nomination Papers of Roland Burris, Candidate for election to the Office of Mayor of the City of Chicago, having convened on February 3, 1995, at 2:00 p.m., in the City Council Chambers, City Hall, Chicago, Illinois; to hear and determine the Objections to the Independent Nomination Papers in the above entitled matter find that:

1. The said Electoral Board has been legally constituted according to the laws of the State of Illinois;
2. Objections to the Nomination Papers of the Candidate herein were duly filed;
3. A Call to the hearing on said Objections was duly issued and served upon the members of the Electoral Board, the Objector and the Candidate, by mail and by personal service, as provided by statute;
4. A public hearing was held on these Objections commencing on February 3, 1995;
5. That the following persons, among others, were present at such hearing: the members of the Electoral Board, the Objector by counsel, and the Candidate by counsel;

6. That on February 6, 1995, the Objector submitted a Withdrawal of Objector's Petition with the Chicago Board of Elections, withdrawing her objections filed against the Nomination Papers of Roland Burris;
7. The Board finds that the Objector has withdrawn her objections and that no other objections have been filed against Roland Burris;

IT IS THEREFORE ORDERED, that the name of Roland Burris, Independent Candidate for election to the office of Mayor of the City of Chicago, shall be printed on the ballot for the April 4, 1995 Municipal General Election.
