## FINDINGS AND DECISION

The duly constituted Electoral Board, consisting of Board of Election Commissioners of the City of Chicago Commissioners Langdon D. Neal and Richard A. Cowen, organized by law in response to a Call issued by Langdon D. Neal, Chairman of said Electoral Board, for the purpose of hearing and passing upon objections ("Objections") of MONICA MARCHETTI ("Objector") to the nomination papers ("Nominating Papers") of ZIFF ANTHONY SISTRUNK, candidate for the office of Mayorfor the City of Chicago ("Candidate") to be elected at the Municipal General Election to be held on February 27, 2007, having convened on January 2, 2007, at 10:00 a.m., in Room 800, 69 West Washington Street, Chicago, Illinois, and having heard and determined the Objections to the Nomination Papers in the above-entitled matter, finds that:

- 1. Objections to the Nomination Papers of the Candidate herein were duly and timely filed.
- 2. The said Electoral Board has been legally constituted according to the laws of the State of Illinois.

- 3. A Call to the hearing on said Objections was duly issued by the Chairman of the Electoral Board and served upon the members of the Electoral Board, the Objector and the Candidate, by registered or certified mail and by Sheriff's service, as provided by statute.
- 4. A public hearing held on these Objections commenced on January 2, 2007 and was continued from time to time.
- 5. The Electoral Board assigned this matter to Hearing Examiner Barbara Goodman for further hearings and proceedings.
- 6. The Objector and the Candidate were directed by the Electoral Board's Call served upon them to appear before the Hearing Examiner on the date and at the time designated in the Call. The following persons, among others, were present at such hearing; the Objector, MONICA MARCHETTI, by counsel, Michael E. Lavelle; and the Candidate, ZIFF ANTHONY SISTRUNK, *pro se*.
- 7. The Board finds that this case is mooted by virtue of the decision rendered by the Electoral Board in case 07-EB-MUN-013, wherein the Candidate's Nomination Papers were found to be invalid.

IT IS THEREFORE ORDERED the Objections of MONICA MARCHETTI are moot.

## **HEARING EXAMINER'S REPORT**

This cause came to be heard before this Hearing Examiner on January 2, 2007. The candidate appeared pro se and the objector appeared through counsel. At that time, the parties were given an opportunity to file preliminary motions and responses. The parties declined the opportunity to file preliminary motions. The matter was continued for further hearing on January 8, 2007.

The Objector's Petition alleged that the candidate failed to file a sufficient number of signatures for placement on the ballot. In related case 07-EB-MUN-013 it was determined that the candidate's nominating papers were invalid. As a result, the instant objections are rendered moot.

For the foregoing reasons, it is my recommendation that the Objections of MONICA MARCHETTI to the nominating papers of ZIFF ANTHONY SISTRUNK be neither sustained nor overruled as the objections are moot
